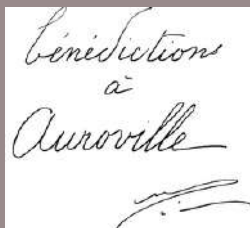

NOTE:

- A Newcomer becomes an 'Aurovillian' once his/her name has been confirmed by The Admission Committee (aka the Entry Board) after following due process.
- The date of becoming 'Aurovillian' is the date of confirmation. An Aurovillian confirmed by the Entry Board is eligible to participate in all community decision-making processes.
- The formal administrative step of entering new residents into the Register of Residents (RoR), is done by the Secretary of the Auroville Foundation. For this, a B-Form is filled in and signed by the individual and a meeting with the Secretary is arranged by the Entry Secretariat. However, until such time as a new Secretary is appointed, the meetings of Confirmed Aurovilians with the Secretary will be pending.

FROM THE AUROVILLE COUNCIL

WHEN AN AUROVILIAN IS ASKED TO LEAVE A WORK-PLACE

Dear Community Members,

For some time, there has been concern about defining a fair and open process for the dismissal of Aurovilians from their workplace. It is believed that such a process should reflect the values that Auroville holds, as well as being an effective means to ensure that units continue to be functional, efficient, and serve the community.

The Auroville Council, together with previous FAMC members, has worked on guidelines for units and trusts to use when there are difficulties with individuals in the workplace that may lead to their dismissal.

We would like to share [these guidelines](#) to gather feedback from the community. The feedback will be considered by the Auroville Council and integrated as needed, after which the document will be issued as guidance. As these guidelines are issued only for guidance, no formal approval will be sought from the RA for the time being.

LETTER SENT TO 'THE HINDU' RE TODAY'S ARTICLE ABOUT VISIT OF THE GB

Dear Community,

Below is a letter that was sent by us to the editor of The Hindu today in response to an article that appeared in today's edition (pg 2; [article attached here](#)) that was based on a press release from unnamed sources regarding the visit of some members of the Governing Board over the last few days.

In the article it is reported that the GB members met with various 'community groups', specifically mentioning the Auroville Town Development Council, FAMC Working Committee and Land Board. It is also stated that "the visit aimed at fostering dialogue and understanding within the community." We have pointed out that there was no interaction with any legitimate representatives of the community and therefore there was no attempt at "fostering dialogue".

Dear Respected Sir,

We were very surprised to read the article "Auroville Governing Board reviews ongoing projects" which was published on page 2 of The Hindu on October 2nd, 2024.

This article is based on a press release which misleads the reader into believing that the small number of residents who met the Governing Board (GB) members are representatives of the larger community. The reality is the opposite and the GB members continue to ignore this in spite of numerous reminders and court orders emphasizing the same. The community and its legitimate working groups were neither informed nor invited to this meeting.

In fact, contrary to what was published, the Governing Board did not meet with the Working Committee of the Residents' Assembly selected by the residents according to Section 20 of the Auroville Foundation Act, and did not extend an invitation to meet them. Neither did they meet with the Town Development Committee selected by the residents. Additionally, the current Land Board that met these four members of the Governing Board has been accused of aiding and abetting transfers of Auroville's land without the permissions required under Rule 309 of GFRs 2017, and without following established due diligence protocols. Furthermore, the Working Committee of the Residents' Assembly and the International Advisory Council (2 of the 3 authorities of the Auroville Foundation) have, on several occasions, apprised the Governing Board of approximately 200 crores of loss due to the illegal transfers. The current Funds and Assets Management Committee appointed by the Governing Board was sent a legal notice from the lawyer of the residents' working groups pointing out the illegality of various decisions and actions by them. The Matrimandir lake excavation is planned, funded and forcibly implemented by a private donor, without the agreement of the Residents' Assembly.

There was no attempt at “fostering dialogue” with the Residents’ Assembly, as stated in the article. The Governing Board has consistently refused to entertain any discussions with the residents and the working groups of the Residents’ Assembly and the claims to move towards “understanding” are untrue.

Therefore, we were extremely surprised to read your article and we ask that in future the views of legitimate representatives of the Residents’ Assembly are sought by your respected publication. We are at your disposal to provide any clarifications or more information.

LEGAL OPINION WITH REGARDS TO AUROVILLE ADMISSION (AKA THE ENTRY BOARD)

Dear family,

We have requested a legal opinion concerning the Admission Committee (aka the Auroville Entry Service). Most readers will be aware that there is currently a case pending in the Madras High Court about a document entitled ‘Auroville Foundation (Admission and Termination of Persons in the Register of Residents) Regulations, 2023’ published in The Gazette of India by the Secretary of the Auroville Foundation on behalf of the Governing Board. While we all await a final judgement on this matter from the High Court, it has granted a stay order. The 3-page legal opinion (which you can read [here](#)), dated 25 July 2024, summarises the matter very well in this final statement:

‘Therefore it is my opinion that the Admissions Committee selected by the Residents Assembly can continue to function under the 2020 Regulations subject to any further or other orders passed by the Hon’ble Madras High Court.’

Essentially what this means is that the Entry Board is doing the following:

1. Contacting the current Newcomers for their self assessments, and other documentation
2. Contacting the mentors for mentor reports and final recommendations
3. Scheduling interviews; processing the current Newcomers to complete their process in one way or another
4. Scheduling clarification on Feedback

Until further notice, the Entry Board will not be accepting new applications for any status in Auroville.

REPORT ON LAND CLEARING AT NINE PALMS ON 1 OCTOBER 2024

On the morning of Thursday, 19 September, the Nine Palms Forest Stewards discovered an area that had been cleared without prior notice. The plot in question, identified as IR379/10, covers approximately half an acre. The cleared vegetation included a few teak trees but mostly work trees and planted and naturally regenerated local species of trees, shrubs and vines typical of the Tropical Dry Evergreen Forest (TDEF) biome. The area had a tree cover density of up to 85%.

The clearing was carried out to create a waste dumping site, with a hole already excavated. This plot is situated in a highly sensitive zone, being directly above a major water catchment area.

The cleared site is located near the highest point of the Rayapudupakam watershed. The first aquifer lies about 15 meters below the surface during summer. During the monsoon season, the road passing through this plot becomes a river, filling a large dam. Once this dam overflows, the water flows into four other dams before reaching the boundaries of Nine Palms. However, overflow only occurs during particularly heavy monsoons, with most water retained within the area.

The soil in this region has high percolation due to a top layer of sand followed by red earth, a sub strata of pebbles. This particular plot has been part of Nine Palms' agricultural land for the past 25 years, it was once used to cultivate local grains and peanuts. The land has been under Nine Palms' care since the community's establishment in the early 1970s. It remains one of the few fertile plots atop the otherwise gravelly and clay-rich hill.

Site Selection

Designating a site as a landfill requires careful site assessment, including the location of the site within the watershed and also the geological strata underneath to check for suitability and to prevent contamination to groundwater and surface water bodies downstream. However, no such process has been followed in the present context.

Impact on the Surface water flow and Groundwater

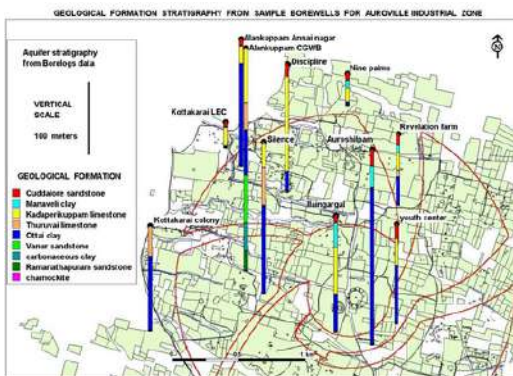
In brief, the site is located on the drainage area of Rayapudupakkam Eri, NW of Nine Palm, and sitting on the main regional aquifer of the area - Cuddalore sandstone, draining in the opposite direction, SE.

The soil is very porous and shows a high infiltration rate, with a visible pebble layer at 3 meters depth.

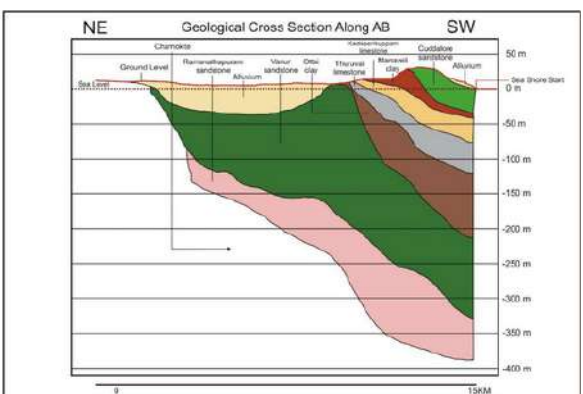
Accordingly, developing a dumping site for waste in this location raises serious concern on risk of surface and groundwater pollution.

Surface water means the potential impact on the land, on the eri and all the irrigated land (Ayacut) depending on this eri. Note that this eri is part of a chain of tank, ending in Kaliveli swamp, recognised by the Government of India as Bird Sanctuary. Disposal of waste in the selected location may pollute the entire chain of tank, Kaluvelli swamp and contaminate the water table. Measures are necessary to prevent pollution transfer through runoff and leaching.

Considering the land's characteristics, the selected site doesn't seem appropriate to host such an activity. Environment concerns will call for a more suitable location, where natural conditions will limit the impact on the water resources. Containment may still be needed but in a much lesser hence more cost-effective way.

Updates as of 01 Oct 2024

The first pit was filled with trash and covered with soil. Subsequently, a second pit has been dug adjacent to it and more trash is being piled inside it.



One can clearly see a pebble stratum at 2 to 3 meters depth. The presence of a pebble layer means that the horizontal movement of the groundwater will be very high. This could eventually lead to a groundwater contamination plume towards Revelation Borewell and also the borewell of the Schools in the cultural zone.

Conclusion

This action is yet again an example where no process is followed and no communication to the public or persons affected occurs. It is understandable that waste needs to be dealt with, but this is certainly not it.

"RED ASSETS LIST": NOTE FROM THE RA-SELECTED WORKING GROUPS TO THE COMMUNITY

As has been explained and repeated numerous times, the ongoing road construction project bypasses Residents' Assembly consultation, and very obviously lacks adequate planning and consideration for existing homes and residents' lives, including instances of haphazard trajectory realignment, substandard quality of materials used, and a glaring lack of road construction signs. Unfortunately, this has led to unwarranted destruction that could have been avoided with more thoughtful planning to spare Auroville assets, be it buildings and man-made structures built with permission from previous planning groups, or natural resources and green spaces that should intrinsically be woven into any urban fabric.

There are feasible alternatives that would allow roads to be constructed without impacting our community's assets. We once more encourage a reassessment of the project to explore these options and prevent further damage to the homes and living spaces of all residents of Auroville, and the further degradation of Auroville's community spirit.

It is important to find a balance that respects both development goals and the preservation of the natural environment in which we all live and for which Auroville is renowned. In light of the planetary crisis, it is crucial that development avoids further environmental harm. Sustainable practices must guide urban planning to prevent worsening future challenges.

Participatory planning, involving all community voices, is key to finding solutions that reflect shared values and ensure a resilient, harmonious future for Auroville.

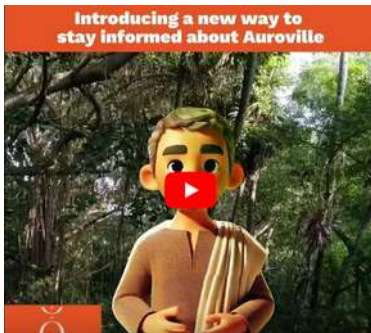

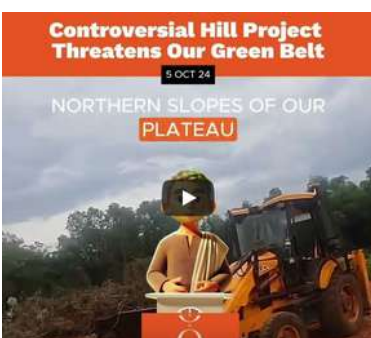

RAISING 'HOPE' ONE DOG HOUSE AT A TIME:
YOUTH CENTRE AND YOUTHLINK STEP IN



We are beyond grateful to the wonderful teams at the Youth Centre and Youthlink for their incredible support in building 20 new dog houses for our shelter! With the monsoon fast approaching, and our old shelter overcrowded and in disrepair, these efforts couldn't come at a more crucial time. The situation at the old shelter has become dire, with crumbling facilities and delays in constructing the new Auroville Dog Shelter, largely due to external sabotage by certain individuals. We simply cannot let our dogs endure another rainy season under such dangerous conditions—last year's flooding turned part of the shelter into a lake, threatening the lives of our animals.



To counter this, we have transformed an unused 0.3-acre section of the old shelter, previously overgrown and prone to flooding, into a secure and vibrant space we call "HOPE." After clearing the area of thick undergrowth, we fenced it in and installed drainage systems and a water-holding pond to ensure it remains dry throughout the monsoon. While we've made significant progress, there's still work to do. We are currently working

on dividing the space into large outdoor areas for around 50 to 60 dogs and hope to raise the ground using leftover material from the Matrimandir Lake excavation. This will allow us to plant trees, bushes, and flowers, creating a beautiful and shaded dog sanctuary, where the colorful houses crafted by Auroville's best Youth will be placed.

We're inviting the AV Community to join the "Dog House Painting Workshop" this Friday, October 11th, and Saturday, 12th at Youth Centre from 9:30 a.m. Support us by add the finishing artistic touches to the dog houses!

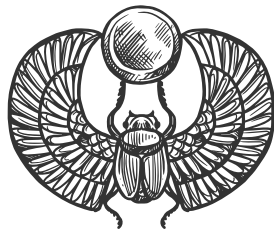

ON LAND CONSOLIDATION WITHIN THE MASTER PLAN AREA

AN APPEAL TO DIVINITY BEYOND OPINION:

The following is my personal view, which I feel compelled to share after much reflection. My intention is simply self-expression, not to seek agreement, validation, scorn, or corrections. This is not presented as a solution to an issue – it is an appeal beyond the mind, directed toward the reader's nascent sense of divinity. A call from one to the many "so that the new things may manifest and we may be ready to receive them." Feedback that comes from the reader's deeper divine place within will be received with gratitude. Any response rooted in the ego will be disregarded with empathy. Thank you for reading till the very end.

Land consolidation within the Master Plan area over the past 2 years seems to have raised eyebrows. Mine for sure. The method of operation by the office of the Secretary to the Governing Board of the Auroville Foundation (AVFO) seems to have been based on aggressive acquisition tactics, often bypassing community consultation, established procedures and undue financial loss. It is safe to say, from their past actions, that they have adopted the belief that the only way to consolidate land within Auroville's Master Plan Area is for Auroville Foundation to own all the land, at any cost. This belief warrants critical examination and redirection. Three key concepts: "only way," "own" and "at any cost" —need introspection.

Only way: In one of the recent community processes that began in 2016/2017, aimed at integrating all possible ways to protect the lands of Auroville within the Master Plan (MP) Area, a task force known as the Land Protection Group was formed by the community. The Land Protection Group is a task-oriented team dedicated to investigating and interacting with agencies and officials to collect, analyse, and inform the community about options for obtaining a statutory legal framework for Auroville's planning and development.

In January 2020, the Land Protection Group shared a comprehensive status report, available on [Auronet](#) which outlined their findings and recommendations. Among at least three feasible ways forward, one notable aim was the "creation of unique statutory land regulation frameworks for Auroville, tailor-made to the uniqueness of the project."

A careful review of this report reveals the colossal work the community has been doing in consolidating the lands within the MP area, even before the current Governing Board and its related bodies came into effect.

Ownership was not the only solution being considered. The community has actively explored various strategies to protect Auroville's lands, emphasizing collaboration, legal innovation, and sustainable development, demonstrating that the path to building Auroville goes beyond mere land acquisition.

Own/Ownership: The Mother always emphasized the importance of relinquishing attachment to material possessions. She stated, "The Aurovilian must lose the proprietary sense of possession..." (refer to point 3 in "To be a True Aurovilian"). Influenced by this beacon of light, the community has cherished a collective value of non-ownership, particularly of immovable assets, such as land and buildings. Those who live on Auroville's land are considered "stewards," not "owners," responsible for caring for the land, or building, rather than possessing or owning it.

While owning all the land within the Master Plan (MP) area of Auroville would theoretically protect it from being used inconsistently with the intended usage as per the MP perspective 2025, practically speaking it is almost impossible to own all of it as nearly 600 acres within the MP Area are occupied by several village settlements and temple lands.

Even though ownership might seem to the current administration as a way to ensure synchronized development within Auroville's MP area, as we can see it is nearly impossible and is coming at a terrible cost, ignoring the fact that other options to consolidate the lands within the MP area still exist.

At Any Cost: The AVFO, with the endorsement of the Governing Board (GB), appears to have adopted a method of consolidating all land within the Master Plan (MP) area based on the belief that the end justifies the means. This approach, however, is causing unparalleled collateral damage. Is it worth it? Let's examine the implications:

A massbulletin dated 08.05.2024 from the Working Committee of the Residents' Assembly (RA WCom) reports on land exchanges, stating there have been opaque land exchange processes conducted by the Auroville Foundation's Governing Board and its related bodies, which have led to significant financial and ethical discrepancies and the loss of very valuable lands on state and national highway. Some key concerns are:

1. Lack of transparency in recent land exchanges, bypassing consultation with key committees and stakeholders, especially the community with a lack of assured security for the residents who still live on the land, or may have to be relocated. Reference to the AuroOrchard, Felicity and Djaima land exchange cases.
2. Allegations of undervaluation of Auroville lands, resulting in significant (more than ₹150 Crores or US \$18 million) financial losses.
3. Disregard for established procedures, including independent valuation and government approvals. An RTI request from the RA WCom answered by the Ministry of Education, India, states, "M/o Education has not sanctioned anything related to sales/exchanges/leases/disposals of land to the AVF yet. However, this Ministry has issued Checklist/principles for Governing Board to approve land exchange or purchase proposals." This reply of the RTI was dated 5th December, 2023.
4. Failure to uphold the principles of mandatory community (Residents' Assembly) consultation and adherence to Auroville's founding ideals.



The detailed Land Report by the RA WCom in the month of May, 2024, substantiates these concerns and informs the community of the same.

This method, applied over the past 2 years by the AVFO, of land consolidation raises serious questions about its worth, considering the significant financial losses, lack of transparency, division amongst people, and departure from Auroville's founding principles.

So, now what?

It begs introspection: is there an alternative way to ensure development remains aligned with the MP perspective, even if the land is owned by private owners within the MP area? Is there not a more harmonious and transparent approach that can align with the community's founding ideals and still achieve the aspired development within the MP area?

Building Auroville: A Vision of Unity, Not Ownership at any Cost

Could there not exist another way to build Auroville, the city the earth needs, according to the Master Plan Perspective 2025, which is not necessarily through owning all the lands within the intended MP area. What guarantees Auroville will manifest as a shining example for the world by simply buying or exchanging land at any cost, or by removing private landowners or relocating thousands of people living on and using 600+ acres of village land, temple lands, and outlying Auroville lands?

Can Auroville not be built by the Auroville Foundation exemplifying human unity, uniting, and inspiring private landowners, neighbouring villages, and temple lands while building the city. Wouldn't this approach foster a community based on collaboration, mutual respect, and shared vision, ensuring with more success that Auroville remains true to its founding ideals while manifesting itself in matter?

If anything needs to be "owned," it is the Dream by the non-Aurovilians rather than the land by Auroville Foundation.

Yet, the idea of "consolidating the land by owning the Dream, not the land, regardless of one's Aurovilian status" is daunting for many. This hesitation comes from a lack of trust—a fear that if you don't officially declare allegiance to Auroville by registering as an Aurovilian, you may have vested interests or be seen as using Auroville for personal gain. While this perception understandably exists, we must rise above it. Our true work is to unite people, regardless of their Aurovilian status, through progressive harmony.

Though administrative categorization of the people may be necessary, at the level of the Dream and Human Unity, a diviner law ought to replace such divisions. Auroville is not just an asset to be managed with rules, it is primarily a vision to be realized through a diviner law.

What could be a diviner law of land consolidation?

When it comes to consolidating land in the MP area, the diviner law that ought to guide us shall be shaped by the overarching aim of human unity. Does someone's financial status, race, nationality, gender, or age matter when it comes to bringing people together? Then why should the Aurovilian status be a barrier to consolidating land? Why is a private landowner supposedly less trustworthy than a registered Aurovilian? Can a private landowner not be inspired to "own the Dream"?

To support this greater aim of unity, can we not create practical arrangements that allow private landowners to collaborate with Auroville within a framework (a resolution submitted by the united Auroville Foundation and passed by the Indian government for example), that aligns with the Dream?

We must appeal to the innate goodness in people, even if past experiences may suggest otherwise. People long to be part of something larger than themselves. The real challenge is not just to consolidate land, but to consolidate humanity—to inspire all landowners within the MP area to align with Her Dream.

This is the true experiment we are called to undertake on the ground.

Rising to the Dream

While all this may understandably sound like fluff to many a practical and rational minds, the Dream still calls us to rise to the occasion, yet again, today, beyond and despite our past experiences, to **apply** human unity especially in something as tangible and challenging as land consolidation in the MP area. Instead of fighting humanity to consolidate land, let's consolidate humanity to fight "*the past that seeks to endure.*"

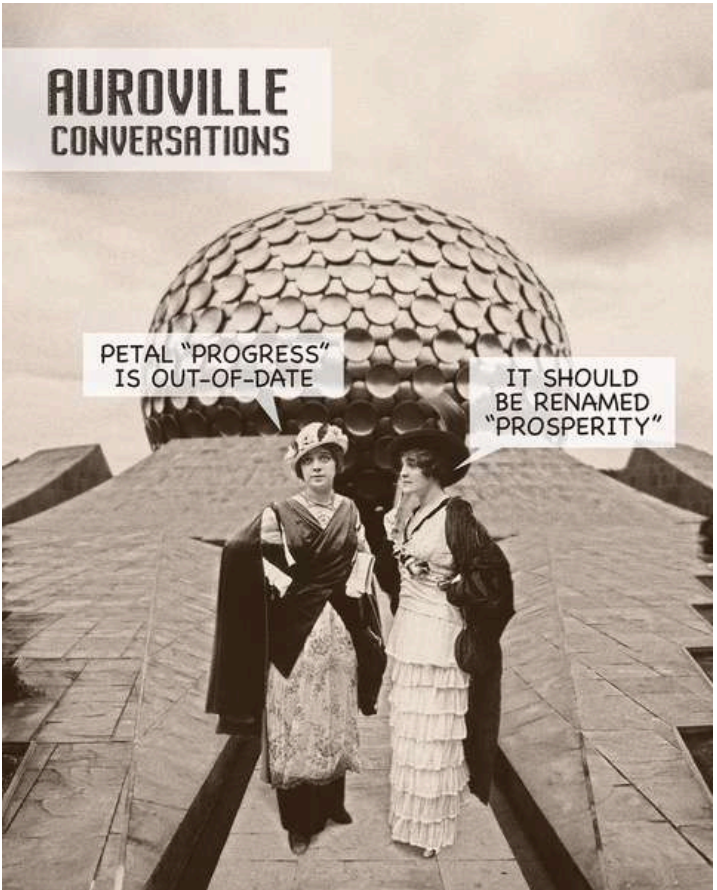

BON VOYAGE SOHAM



Soham (Jacques C H Philippeau) came to Auroville in 1987, together with his former partner Djouna. He was in Auroville continuously till he passed away at his home in Transformation on 19th September, 2024, due to cancer. He was 73 years old.

Soham spent some of his younger years in Corsica, on an isolated goat farm, where it was hard to get even essential amenities. He continued this simple life in Auroville. He is known to have been a disciplined and hard worker. As a lover of flowers and nature, he worked for a long time in the Matrimandir Nursery's hibiscus garden, and tended with meticulous care to his own garden in Transformation, sharing his plants and flowers with others.

Many years ago Soham lost his voice due to cancer of the throat and began to feel isolated, and eventually fell prey to depression. He worked on overcoming the instability in parts of his being with the help of Dr. Alok Pandey. One of his carers mentioned that a recent insight of his was that his yoga was a selfish one and that he hurt people because of this. Physically he had to face many difficulties but managed to address his health problems using alternative means, and in the meantime kept his discipline and ability to smile. Soham was a gifted artist.

He showed a deep understanding of mandala symbolism and intricate design. He recently donated his mandalas and other paintings to Art for Land. His paintings can be seen online in the website of Art for Land, artforland.in.

He was immersed in the Mother's and Sri Aurobindo's writings and, at the same time, kept himself informed about what happened in Auroville and the world outside. He occasionally published long extracts from Sri Aurobindo's works in the weekly News & Notes, adding his -- equally long -- unusual comments and distinctive views about Auroville and the world to it.

During his last few months, Soham volunteered and was happy to do shopping for Mahalakshmi Home.

His neighbour of many years, Hans van Baaren, wrote the following heartfelt message:

"There is a wonder to have been a witness to your life, Soham. You had many adventures and trials and tribulations. You are a great soul and a warrior to have gone through so many physical hardships. And often with a total dedication and a smile. It was amazing to have known you. Bon voyage."

IN MEMORIAM:

MAGGI LIDCHI-GRASSI (1930-2024)

We regret to inform the Auroville community of the passing of Maggi Lidchi-Grassi, an esteemed Friend of Auroville, who passed away on the 30th of September 2024, in the early hours of the morning at her residence behind Fertile, at the age of 94.



Maggi was born in Paris on the 9th of May 1930. She first visited the Sri Aurobindo Ashram in 1959 and settled there permanently in 1960. She was well-known as an author of works such as *Earthman*, *First Wife*, *Great Sir* and *Heavenly Lady*, *The Great Golden Sacrifice of the Mahabharata*, and *The Light That Shone into the Dark Abyss*. She also founded *Domani*, an Italian magazine where the teachings of the Mother and Sri Aurobindo were shared. Additionally, she was actively involved in the publication of *World Union*, the Ashram's magazine.

Beyond her literary contributions, Maggi is remembered as a homeopath and as Mother's secretary. She was responsible for taking letters from Aurovilians to the Mother, arranging appointments for those who wished to meet with Her, and maintaining the birth records for children born in Auroville after Mother's passing.

Maggi also had the honor of being one of the voices to read Auroville's Charter during the inauguration ceremony on the 28th of February 1968.

A devoted follower of the Mother, Maggi played an important role in Auroville's early developments. Together with Nata, she prepared the amphitheater for the inauguration ceremony, while Vincenzo prepared the urn. She and Nata also co-founded *Auroshika*, an incense-making unit in Edayanchavadi, and later, they established *Udavi*, initially a school for the children of the women working at *Auroshika*. Over the years, *Udavi* has grown into a well-established and recognized school in the community.

Maggi also started the very first Free-Store within the grocery shop that Nata had set up in Edayanchavadi. She later founded the *Quiet Healing Center* and, more recently, was working on a new project called *Stillness*—a retreat center she was developing with her companion and partner, *Surakshita*.

Guna (from Avdesign) has been an incredible loyal support acting as a son for many years.

Rajsekar (Growing Towards Foundation) has been an incredible pillar.

Her Companion *Surakshita*.

Her children- *Rani*, *Ishita*, *Xavier*, *Tiffany*, and *Parasu*.

Her grandchildren - *Florian*, *Ayesha*, *Noémie*, *Emma* and *Aria*.

And all of her Friends, heart and soul Family, collaborators and partners will miss her dearly but trust that she is with Mother, going on with Her work.

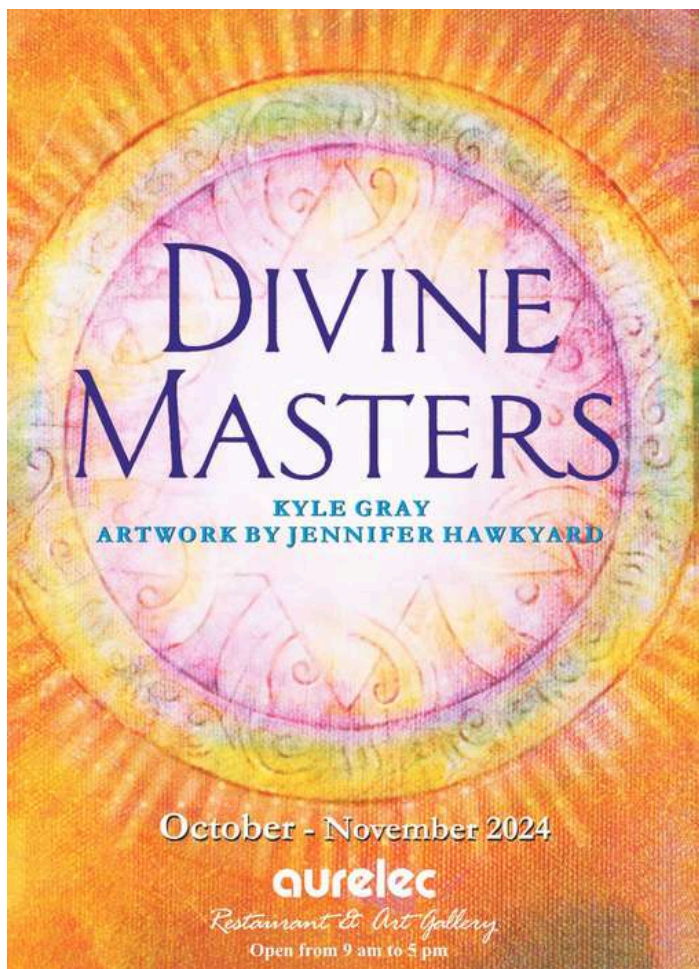

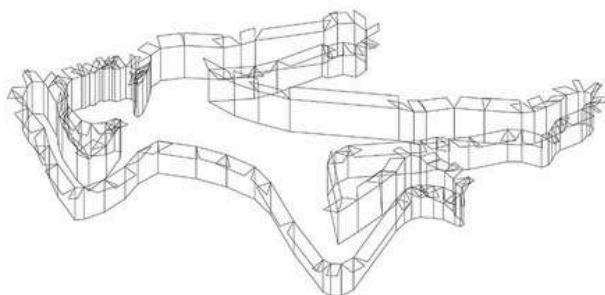
